## WHAT WE BELIEVE

1. We believe education is the right, privilege and responsibility of the parent. The admonition in Proverbs 22:6 to “train up a child in the way he should go” was given parents with the promise of success. God in His wisdom has provided special help for the parent in the form of other Godly adults with special talents or gifts in the important area of teaching. It thus becomes the obligation of the parent to either personally provide that training or to delegate that responsibility to someone of similar beliefs and special ability. Before God, we will stand accountable for the influence we have exerted on our children, and also for those influences we have allowed to mold attitudes, beliefs, and behavior of those precious children given into our temporary care.

2. We believe that the Word of God, the Bible, must not only be taught as a subject in our school, but also be used to form the principles and premises upon which every subject must be taught. That is not to imply that Seaford Christian Academy will teach only the Bible, but that the Bible, as absolute truth, demands that history be taught as His history beginning with Adam and Eve, that life science be taught from a creationist vantage point, and that economics be developed in light of man as a steward of God's gifts. Simply speaking, Biblical principles by their nature must be the controlling factor in every academic discipline.

3. We believe that mediocrity in any area of school life is not an acceptable condition for a Christ-centered institution. It shall be necessary for both faculty and student body to put forth their best effort in reaching spiritual and academic goals. The distinctive ministry of Seaford Christian Academy must be their commitment to the training and preparation of exceptional Christians, patriotic citizens, and academic students of highest caliber. That commitment demands a qualified staff, a well-coordinated curriculum and a highly-motivated student body. These goals do not imply that a high I.Q. is a prerequisite for attending, or that A or B Grades are a must, but that a maximum of effort is necessary on the part of every staff member and student.

4. We believe that the teaching of submission to the Word of God, parents, and those placed in authority is an essential part of any child's education. Seaford Christian Academy shall develop and enforce with both love and consistency those standards, which we deem necessary in developing the Christian character, we desire and which the Word of God demands. Some rules shall be developed with regard to modesty, and some will relate totally to classroom control and character building. We believe the Bible provides for corporal punishment in cases where other forms of encouragement have not proven effective. If repeated discipline is necessary and does not affect the proper character and attitude changes, the child will be withdrawn from Seaford Christian Academy.

5. We believe that parents are responsible before God for their child and the training given that child. Thus, it is inherent that each parent chooses a school that they can wholeheartedly support. That support must apply to the way discipline is administered, the type of curriculum being used, the payment of tuition, and the attitude of parents toward their teacher. The effective training of a child and his/her development spiritually, academically, socially and physically demands a Godly unity of parent, teacher and administration. The school cannot tear down the home without driving a wedge into the development process. In the same way, the parent must support the school. When school and home cannot agree, the child must be removed before irreparable harm is done.
